Usage of our services

We will also provide information to the authorities if required by law.

Witscraft B.V. may also collect information of visitors of this website to be used for its business operation, in order to generally inform clients and to keep statistics of usage of this website.

We do not collect or use information for purposes other than those described above.

Communication

When you send e-mail or other messages to us, we may retain those messages. Sometimes we ask you to provide (additional) personal details that are relevant for the specific situation. This makes it possible to process your questions and answer your requests.

Cookies
